Cyprus Residency by Investment Programme

Permanent Residency Criteria

- Purchase one or two new real estate properties for 300.000 EUR + VAT (same developer)
- Transfer from abroad 30.000 EUR fixed deposit for 3 years to a Cyprus bank account
- Have steady annual income from abroad transferred to bank account in Cyprus
- Have clean criminal record from the country of residence

Permanent Residency Program Benefits

- Lifetime Permanent Residency within 90 days
- Visa Free enter and the right to live in Cyprus for PRP holders
- Dependent spouse, children up to 25 y. and parents can qualify
- Knowledge of the Greek Language is not required
- Favorable Tax system for Residents Non-Domiciled and Corporate
- No requirements to stay permanently in Cyprus (must visit once every 2 years)
- High standard of education and medical facilities

Cyprus Citizenship by Investment Programme

Citizenship Criteria

- Investor must be at least 18 years old and a holder of a Cyprus Residency permit
- Applicant and Dependent persons must have Clean Criminal Record from country of Residence
- Acquisition of Lifetime Residence of minimum 500.000 EUR + VAT
- Investment of 2M (4 options) and keep it for at least 3 years from the date of naturalization

Citizenship Program Benefits

- Passport issued within 6 months
- Dual Citizenship is allowed
- Visa Free to 169 countries worldwide
- Access to the best educational & health care centers
- Family members (spouse and children up to 28 years) are granted the right to citizenship
- Parents and In-laws can apply as dependents if they purchase a house of min. 5K EUR + VAT.
- No requirement to reside in Cyprus before, during or after the application
- Knowledge of Greek Language is not a requirement
- Tax residency based on number of days spent in Cyprus each year (183 days)
- No restrictions to Nationalities of applicants

PASSPORT FOR INVESTOR AND DEPENDANTS

Lifetime Residence (Applicable for all options 1-4)
Any amount in excess of the minimum €500,000 reduces the total investment accordingly.

*Immovable Property
It refers to the residential and/or other infrastructure projects

If the investment is made exclusively on residential property/ies, then the amount of the investment is reduced to €1.5M + VAT

It refers to units in AIFs and financial assets such as bonds, securities debentures of Cypriot businesses or organizations which are licensed by the Cyprus Securities and Exchange Commissions.

The investor under Option 4 has the choice to invest up to a maximum of €500,000 in Government Bonds in order to satisfy the needed investment of €2M.
